Privacy Policy

Collection of your Personal Information

To better provide you with products and services offered, Stone Fleet may collect personally identifiable information, such as your:

Mailing Address

E-mail Address

Phone Number

Job Title

We collect billing and credit card information if you purchase products and services from Stone Fleet. This information is used to complete the purchase transaction. We do not collect your personal information unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. Use of your Personal Information

Stone Fleet collects and uses your personal information to operate and deliver the services you have requested. Stone Fleet may also use your personally identifiable information to inform you of other products or services available from Stone Fleet and its affiliates.

Sharing Information with Third Parties

Stone Fleet does not sell, rent, or lease its customer lists to third parties. From time to time, Stone Fleet may contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. Stone Fleet may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange deliveries. All such third parties are prohibited from using your personal information except to provide these services to Stone Fleet, and they are required to maintain the confidentiality of your information.

Stone Fleet may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Stone Fleet or the site; (b) protect and defend the rights or

property of Stone Fleet; and/or (c) act under exigent circumstances to protect the personal safety of users of Stone Fleet, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Stone Fleet. Use of Cookies

The Stone Fleet website may use "cookies" to help you personalize your online experience. A cookie is a text file placed on your hard disk by a web page server. Debug to identify and repair errors that impair existing intended functionality;

Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;

Comply with the California Electronic Communications Privacy Act;

Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
